Purpose of the project / proposal

The National Park Management Plan update is a statutory document prepared by the National Park Authority, but closely involving all the main organisations with responsibilities and interests in the National Park. These comprise: Environment Agency, Forestry Commission, Hampshire County Council, National Park Authority, Natural England, New Forest District Council, Test Valley Borough Council, Wiltshire Council, Verderers of the New Forest.

It brings together a range of proposed actions by these and other organisations that will help to deliver the two statutory purposes and duty of the National Park, as required by the Environment Act 1995. The Plan focuses on objectives and actions for the forthcoming five years (2015-20). It also summarises recent changes in national policy and gives examples of recently completed partnership projects.

Consultation

Has a consultation been carried out?

Extensive public consultation has been carried out on both an initial draft of the Plan (9 week 'Call for Views' consultation) and revised draft (6 week formal consultation). The consultations were widely advertised to organisations, communities and residents, including circulation to around 300 organisations, discussion with specific interest groups, website information, posters on public notice boards, press coverage and public drop-in sessions.

It is hoped that the Plan will be endorsed by all the main partner organisations and published in autumn 2015. A copy of the final document will be lodged with the Secretary of State.

The Plan has also been subject to a Sustainability Appraisal (including Strategic Environmental Assessment) and Habitats Regulations Screening Report
