<p><b>Additional Plans</b></p>	<p>The national requirements note the need for a location plan and “others as necessary” with a reliance on the local requirements to detail what those are. For the avoidance of doubt the local requirements should confirm what we need (particularly for the local requirement of calculating floorspace)</p> <ul style="list-style-type: none"> <li>• Block plan including site access details</li> <li>• Existing and proposed elevations and floorplans in full.
