Oak tree to be reduced and deadwood the whole crown, thin where necessary. Fir tree is growing into Oaks crown. Has been planted to close and will cause rubbing problems and potential limb failure. This will also thin the clients 'woodland'. Tree to be dismantled to ground level.
