ANNUAL INTERNAL AUDIT REPORT AND OPINION

1 Purpose

1.1 The purpose of this report is to provide the Resources, Audit and Performance Committee with the Chief Internal Auditor's opinion on the adequacy and effectiveness of the New Forest National Park Authority's (the Authority's) framework of risk management, control and governance processes for the year ending 31 March 2020.

2 Summary

- 2.1 In accordance with proper internal audit practices, the Chief Internal Auditor is required to provide a written report reviewing the effectiveness of the system of internal control to inform the production of the Annual Governance Statement.
- 2.2 The Annual Report for 2019-20 (attached at **Annex 1**) provides the Chief Internal Auditor's opinion on the adequacy and effectiveness the Authority's framework of risk management, control and governance processes and summarises audit work from which that opinion is derived for the year ending 31 March 2020.
- 2.3 The Resources, Audit and Performance Committee's attention is drawn to the following points:
 - Internal audit was compliant with the Public Sector Internal Audit Standards during 2019-20;
 - The internal audit plan for 2019-20 has been substantially delivered;
 - The Authority's framework of governance, risk management and management control is considered to be 'Substantial' and audit testing has demonstrated controls to be working in practice;
 - Where internal audit work identified areas where management controls could be improved or where systems and laid down procedures were not fully followed, appropriate corrective actions and a timescale for improvement were agreed with the responsible officers.

3 Additional Information

- 3.1 The internal audit plan for 2019-20 was approved by the Resources, Audit and Performance Committee on 04 March 2019.
- 3.2 Provision for the delivery of Internal Audit is included within the Authority's Service Level Agreement with New Forest District Council.

4 Recommendation

It is recommended that Members approve the Chief Internal Auditor's Annual Internal Audit Report and Opinion for 2019-20.
