Current outline planning application for Fawley Waterside includes 60 new affordable homes in the National Park. Other housing site allocations in the new local plan are likely to come forward in the short to medium term with additional, significant on-site affordable housing provision. However, consent for five new homes this financial year has not been achieved (two in total, Burley).
