



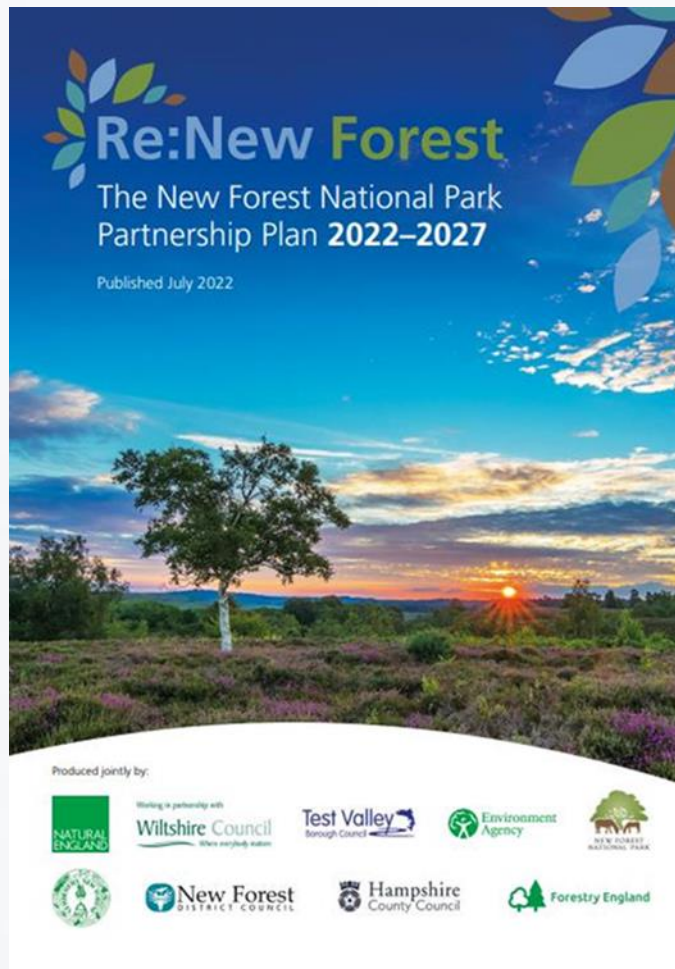

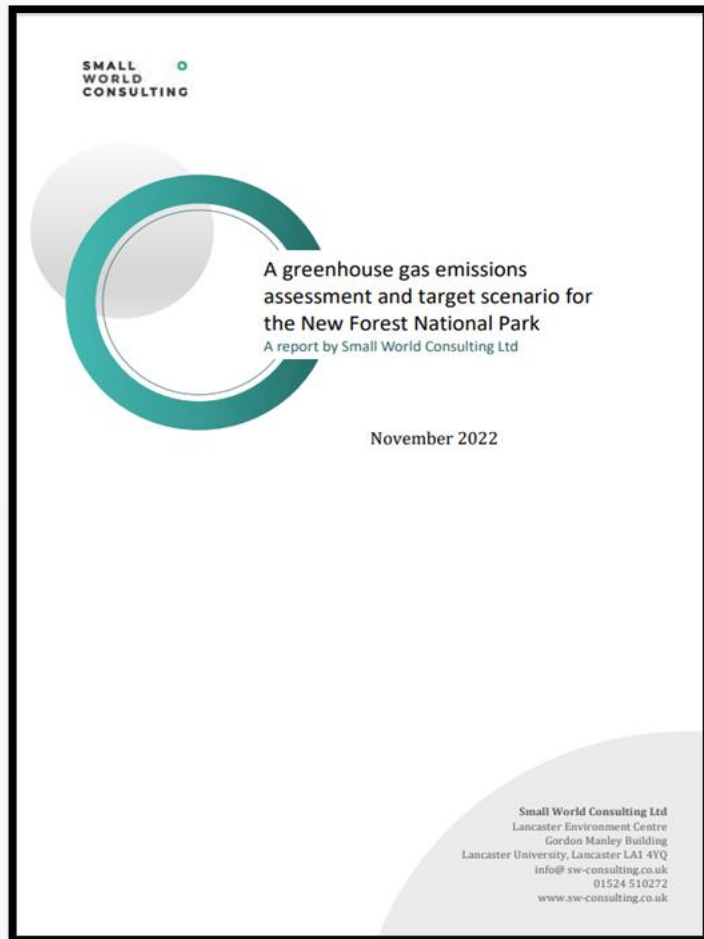

Climate – reaching Net Zero



The report outlines:

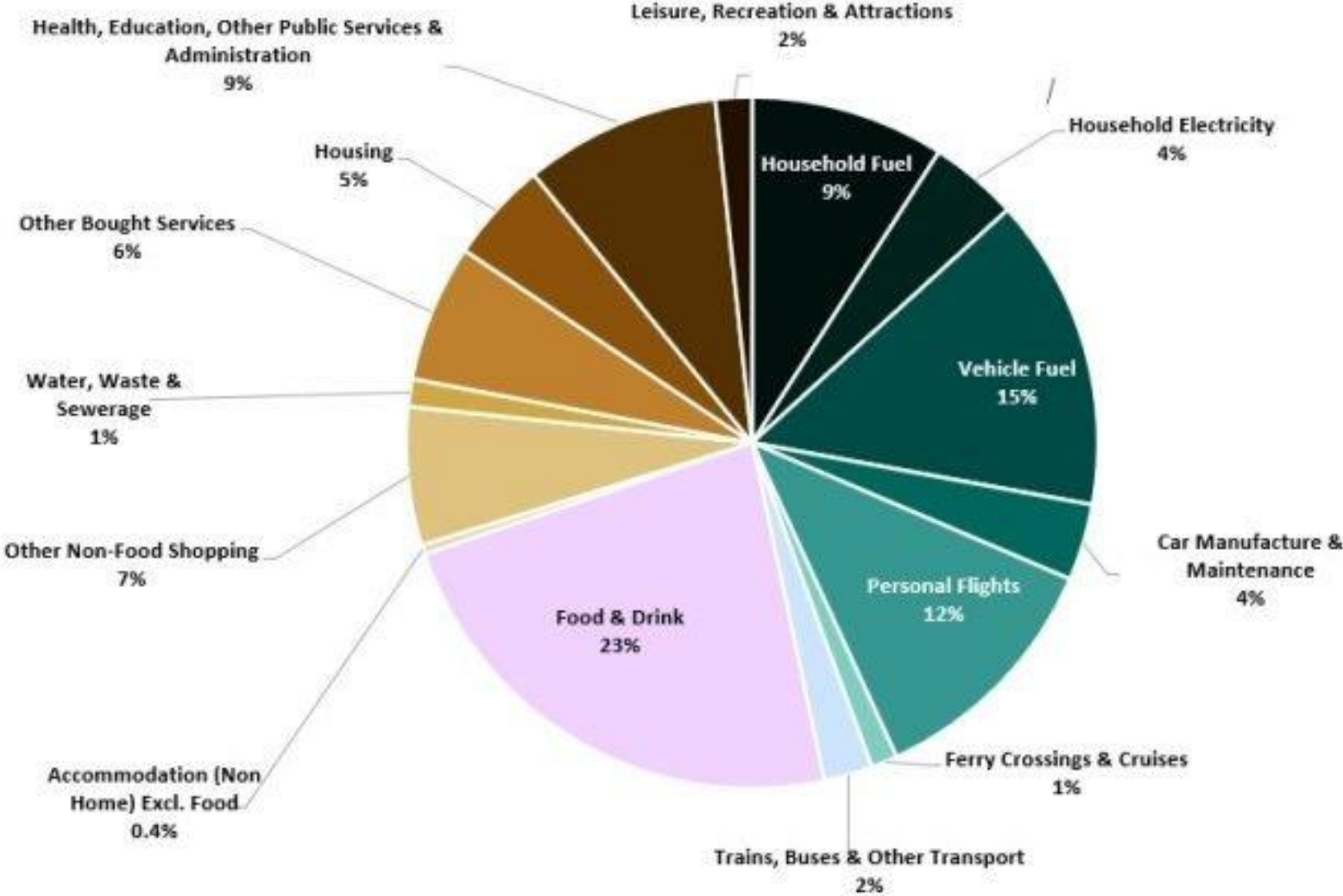
- where emissions arise in the National Park
- the emission reductions that will safeguard against runaway climate change
- recommendations for how everyone who has a stake in the National Park can achieve impact.

Report highlights

- The role residents, visitors, local organisations and businesses can play in building climate resilience locally
- Food & drink are the largest source of emissions associated with residents' lifestyles
- Changes to the way land is managed could result in the National Park removing more emissions from atmosphere annually than it produces
- Lists areas that can play a key role in building resilience such as construction, home energy, food production and diets, travel and transport...

Residents: 540,160 tCO₂e



Nature – Natural Environment Investment Readiness Fund

- New source of funding for environmental projects in England, announced by Defra and the Environment Agency earlier this year
- £100,000 year-long project to develop a model to drive private investment into nature recovery projects
- Forestry England, Cadland and Barker Mills estates involved in pilot
- Project outcomes shared with around 50 landowners

Nature – Habitat Mitigation

- NPA Revised Habitat Mitigation Scheme adopted in 2020
- Seeks contributions from developers to mitigate impacts of new development
- All LPAs have their own mitigation schemes
- A priority in the Partnership Plan is to develop a more strategic approach to habitat mitigation
- LPAs now working together to agree a consistent framework within which contributions are sought

People – Local List project

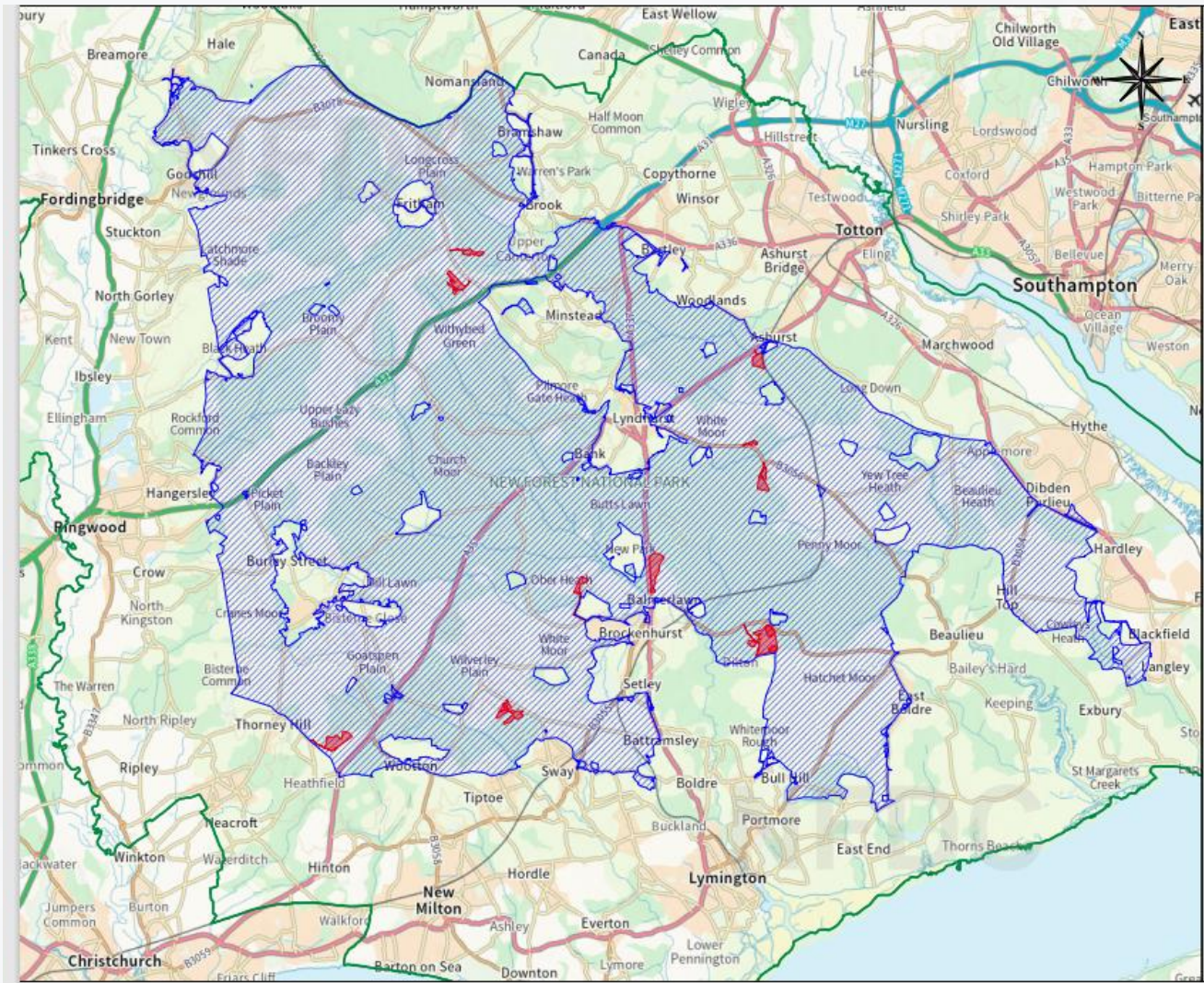


- Recognises the positive role buildings, structures, sites, monuments and other features play in reinforcing local character and the distinctiveness of areas
- Received funding to support work with local communities who can nominate local landmarks for inclusion on the list
- Agreed to add 31 new sites to the local list at last month's Planning Committee meeting

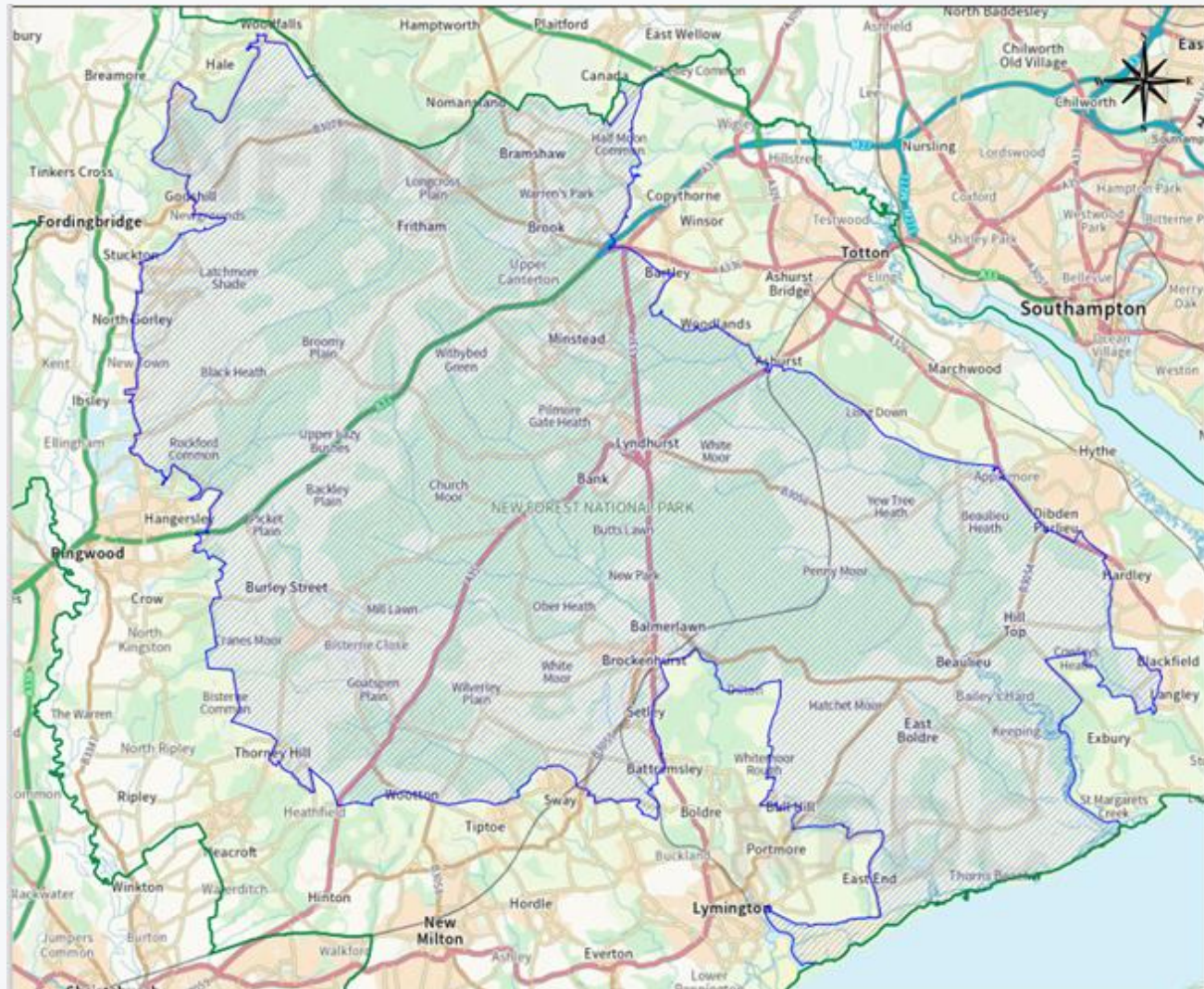
Overview Map

- ~ District Boundary

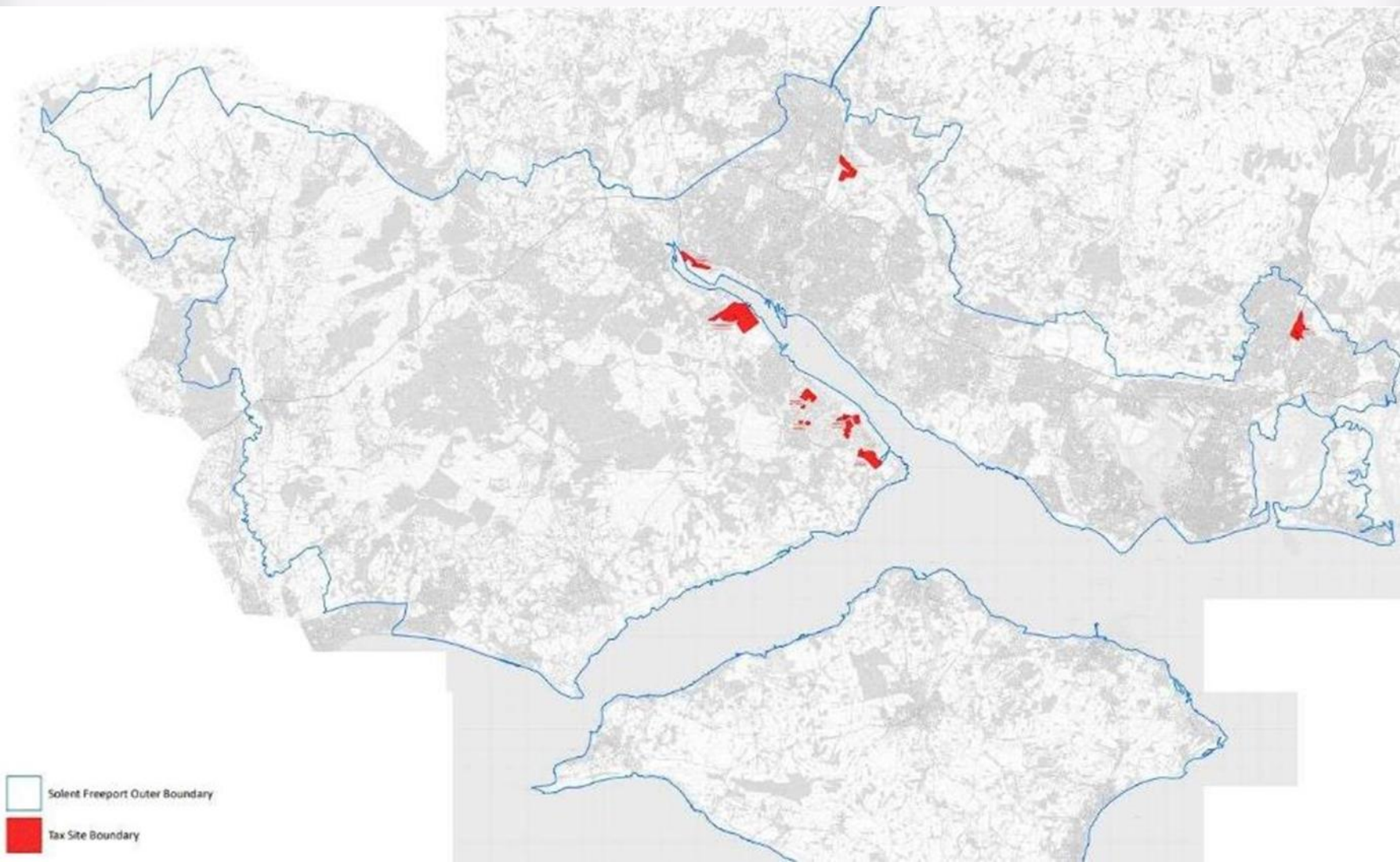

Place - Freeports


- Report to Authority meeting last month
- Special areas within the UK's borders where different economic regulations apply
- Centred around one or more air, rail, or seaport, but can extend up to 45km beyond the port(s) – the 'outer boundary'
- Planning guidance states *“Freeports will provide a supportive planning environment for the development of tax and customs sites through an extension of permitted development rights and incentivising use of local development orders”*




Place – Freeports


- Government response (Sept 22):
- The Outer Boundary indicates the area expected to benefit most directly from the Freeport's economic impacts
- Not earmarked for development or any special planning status
- LPAs will remain responsible for providing planning permission within the Freeport area
- Does not eliminate the need for an EIA
- No proposal to change permitted development rights for Freeports
- NPA continues to seek further clarification

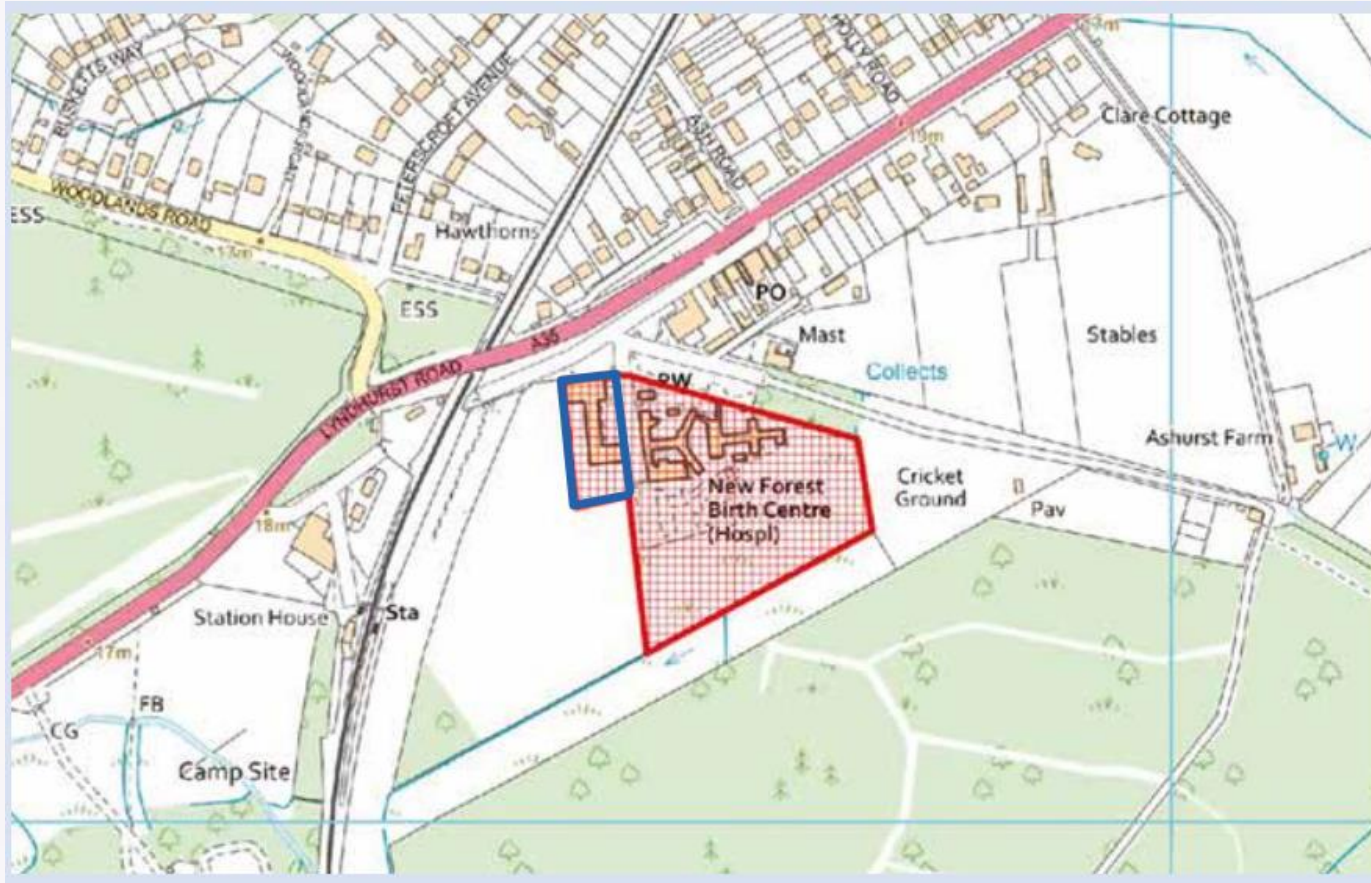

TOWN AND COUNTRY PLANNING ACT 1990 (AS AMENDED BY THE PLANNING AND COMPENSATION ACT 1991)

ENFORCEMENT NOTICE

ISSUED BY: New Forest National Park Authority

1. **THIS IS A FORMAL NOTICE** which is issued by the Authority because it appears to them that there has been a breach of planning control, under section 171A(1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this Notice, having regard to the provisions of the development plan and to other material planning considerations.

2. **THE LAND AFFECTED**

Land at Vernon Dene, Ringwood Road, North Ripley, Bransgore, Christchurch, BH23 8EL shown edged red on the plan attached to this Notice.

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without planning permission, the carrying out of engineering works ('the site works') comprising the laying of hard surfaces for caravan bases, formation of internal roads, driveways, parking spaces, creation of two new paved bell mouth entrances including the erection of boundary walls and brick pillars, and the installation of utility cabinets, water and foul drainage systems, to facilitate the introduction of up to 92 permanently sited caravans on the land affected.

4. **REASONS FOR ISSUING THIS NOTICE**

It appears to the Authority that the above breach of planning control has occurred within the last four years.

The site lies in an area of open countryside within the New Forest National Park and within the catchment of the River Avon Special Area of Conservation (SAC). The site also adjoins the New Forest Site of Special Scientific Interest (SSSI) and lies within 400m of the New Forest Special Area of Conservation (SAC), the New Forest Special Protection Area (SPA) and the New Forest Ramsar.

The Secretary of State has issued a Screening Direction (on 21 April 2022) confirming that the site works are likely to have significant effects on the environment and are 'EIA' development within the meaning of the Town and Country Planning (Environmental Impact Assessment) Regulations 2017.
