This year it's been another successful breeding season for goshawks in the New Forest.

We've set-up a new nest camera that's enabling viewers to see the birds in their natural habitat, up close and personal.

All 3 eggs hatched successfully and the parents are busy tending to the chicks needs. We're hopeful that all 3 will fledge successfully and make their own way in the forest. ## Wildlife - Wetland restoration update

The HLS wetland restoration programme continues - this summer contractors will be returning to sites that were previously worked, to repair small parts of forest streams and mires.

This work aims to maintain the watercourses and help to make sure streams and the surrounding habitats are more resilient in both winter floods and summer droughts.

We're also starting a small, new wetland restoration project in July at Picket Bottom. By restoring the natural watercourse here, it will reduce the speed of the water moving through the area during heavy rain.



We aim to cause minimum obstruction to footpaths and have taken into consideration the popularity of key locations. Only a small number of routes will be affected by the works and alternative footpaths are available.





Our Ranger team continue to remind people about not feeding and petting ponies.

Over the coming weeks we'll be installing the new PSPO signage across the Forest at key locations.

From 1 July, it will be a criminal offence to feed or leave food out for New Forest ponies and donkeys and to touch or pet them.





The new campsite operator has re-opened the sites, ready for this year's season.

We continue to work with Camping New Forest to ensure their campsite management plans are in place, so that this unique and precious environment is protected, whilst also supporting the local community and economy.





### People - Operation Mountie

We continue to be part of Operation Mountie, a multi agency approach to reducing speed and animal deaths across the New Forest, regularly carrying our patrols along Roger Penny Way.

Hampshire Constabulary gave more drivers tickets for speeding and other drivers were spoken to by the New Forest Roads Awareness Team and Forestry England staff and given advice about why New Forest roads are so special.







Forestry England's Rangers and PC Roberts have been carrying out cycle patrols. This includes focussing on high fire risk areas and we will be spending lots of time there, especially now the weather has warmed up.





The recent dry conditions present a higher risk of wildfire here in the south of England.

We continue to work closely with the Hampshire Fire and Rescues Service on sharing key messages with the public and joint patrols across the Forest.

We're reminding people that the New Forest is a strictly no fire or BBQ zone and from 1 July it will be a criminal offence to light or cause a fire or use a BBQ here. There is an exception for Forestry England owned campsites where BBQs or stoves that are purpose built and raised off the ground can be used for cooking. Disposable BBQs are not allowed on any of the campsites or at any other location in the Forest.



# No BBQs or fires

There is a high risk of forest fire. Help us to prevent wildfires and protect the forest.

#### If you see a forest fire:

- Dial 999 and give an exact location.
- Stay safe and wait for the fire and rescue service.
- Show them where the fire is.
- Call the police immediately if you see anyone starting fires deliberately.
