To conserve and enhance the natural beauty, wildlife and cultural heritage of the area

- Lyburn Farm
- Paulton's Park.






#### **Species Survival Fund**

- £1.3m scheme to restore New Forest habitats and increase wildlife.
- £1.04m grant from Species Survival Fund plus match funding.
- Six partners (Freshwater Habitats Trust; Amphibian and Reptile Conservation; Commoners Defence Association: Wildlife Trust, Wild New Forest, NFNPA) plus support from the RSPB and New Forest Biodiversity Forum.
- One of only 20 successful schemes nationwide.
- Hosted visit from Defra's policy and protected sites team to see some of the sites and meet partners.









## Farming in Protected Landscapes

Defra announced extension of FiPL roles for six months after scheme ends – to September 2024 and Farm Advisor role to March 2027.

Over £800,000 in grants will have been allocated by the NFNPA to over 50 projects by the end of the scheme.

Meeting of English NPAs, Defra and Natural England.



#### **Future scheme for the Forest**

How can future agri-environment schemes support commoning and habitat restoration as we move to domestic agricultural policy?

Existing Higher Level Stewardship scheme will come to an end.

Forest organisations calling for a bespoke scheme to better suit local circumstances.

Forest Farming Group (FFG) of Forest organisations wrote to new Secretary of State Steve Reed MP asking for urgent response.

FFG commissioned feasibility study to help determine most appropriate scheme.



### **Fawley Waterside**

Outline planning applications with NFDC and NFNPA withdrawn due to 'wider economic pressures and increased construction costs'.

Fawley Waterside will continue to work with the planning authorities to consider the most appropriate development strategy for the site.



#### Solent CO2 pipeline

- ExxonMobil launched consultation into proposal for underground pipeline to transport CO2 from Fawley Refinery to location in the English Channel.
- Any planning application would be called in and determined by Government.

## Hampshire Minerals and Waste plan

- Led by Hampshire County Council, with NFNPA, Portsmouth City Council, Southampton City Council and South Downs NPA.
- Draft plan, supporting evidence and representations from latest consultation will soon be submitted to Secretary of State for independent examination.
- Is a partial update to the existing plan adopted in 2013.

## Neighbourhood Plans and Village Design Statements

- Residents voted overwhelmingly in favour of a draft Ringwood Neighbourhood Plan in referendum on 4 July and in favour of a draft Wellow Neighbourhood Plan on 11 July.
- The Plans will help the NFNPA and NFDC/Test Valley Borough Council to decide planning applications.



## New Forest Catchment Partnership

- Partnership hosted by NFNPA
- Defra committed a further £15k
- Last year partnership generated £200k cash/in-kind contributions
- 3,317 volunteers involved.

Hosted Chief Executive of Southern Water to visit the Beaulieu area to see freshwater ecosystems with Freshwater Habitats Trust and Environment Agency.





#### Archaeology

Our archaeology team led NPA and NFDC planning staff on a visit to an excavation in advance of a housing development at Fordingbridge.

Hosted annual meeting of Joint UK statement on the Historic Environment in the National Parks (19 heritage staff from 12 national parks, Welsh Government, Forestry England, Historic England, Historic Environment Scotland, Natural England, Natural Resources Wales).

### Enjoy – Second Purpose

To promote opportunities for the understanding and enjoyment of the special qualities of the National Park by the public.



#### Behind the scenes campaign

- Commissioned by the Partnership Plan leaders to increase understanding of how special the National Park is for nature.
- Looks at the wildlife and people behind the scenes.
- Launch at the New Forest Show and theme of our stand.
- Will run for six months to mark the 75th anniversary of UK national parks.





#### **New Forest Code**

Operation Mountie animal accident patrols held with Police, New Forest Roads Awareness and Forestry England stopped over 40 drivers. One driver stopped doing 76mph in a 40mph limit and failed a drug test.

Two joint sessions with Police and New Forest Dog Owners group to educate people about ground-nesting birds and livestock with young offspring.

- Junior rangers 34 signed up for monthly sessions (top right).
- Youth board nine young adults signed up.
- Early Green Careers Network 44 registered.
- Work experience for Year 10 pupils. Four schools participating.

## Access to nature for young people

Defra funding for young people's access to nature through Access Unlimited Consortium.

Project will give underserved young people in England a chance to spend time visiting and connecting with nature in protected landscapes.



#### **Arts and Culture**

- Yarrow Townsend appointed first writer in residence in a project by arts development agency Artful Scribe in conjunction with the Countryside Education Trust in Beaulieu, with a grant from our Sustainable Communities Fund.
- Artists in residence programme: Alex Julyan and Ben Adamson took part in the residency during October 2023 and exhibited their work (right) at spudWORKS in Sway during May. Jasper Rouwen took part in the residency during May and will exhibit at spudWORKS in October.
- Culture in Common D-Day anniversary commemorations.
- Cultural quarter at the New Forest Show.





### New Forest Awakening Festival

- Annual climate and nature festival, now in its fourth year.
- 3,000 people attended 90 events organised by over 50 partners.
- Events included walks, talks, theatre, arts and crafts, a local produce roadshow, growing advice, climate-themed events, litter picks, behind the scenes tours, and early green careers advice.
- Messages reached more than 1.5 million people through social and traditional media channels.



#### **Health Fellows**

- Two new NHS Public Health fellows join us in August working two days a week.
- Supported by Hampshire County Council's Public Health team.



#### **Prosper – Our Duty**

Working in partnership with other organisations it is also the Authority's duty to seek to foster the economic and social well-being of the local communities within the National Park.



#### **New Forest Tour**

NF Tour launch on 29 June.

20<sup>th</sup> anniversary marked by goodie bags to first group of customers.

#### **New Forest Marque**

- Members visit.
- SLA renewed to provide comms support and hosting the Marque.
- Currently 171 members in part thanks to Marque Inspired scheme launched for arts and crafts.
- New Marque local produce guide has been printed.
- Events include Netley Marsh Steam Rally, Damerham Fair, New Forest Food Festival, Ellingham Show and New Forest Show.
- 20<sup>th</sup> anniversary launch at the New Forest Show.



#### **Tourism sector**

Working with hotel groups to promote our caring for the Forest messaging, the code, walking app, Tour and other sustainable tourism approaches.





