## APPOINTMENTS TO VACANCIES ON COMMITTEES AND EXTERNAL BODIES

#### 1. New Members

- 1.1 Members are advised that two new members have been appointed to the NPA Malcolm Wade has replaced Neville Penman as Hampshire County Council representative on the Authority and John Adams has been appointed as Secretary of State (Parish) appointee following the sad death of Steven Tarling and a lengthy delay in the confirmation of that appointment by Defra.
- 1.2 At the Annual Authority meeting on 17 October 2024, members appointed the membership of committees and appointments to external bodies for the ensuing year.
- 1.3 Neville Penman was appointed to the Resources, Audit and Performance Committee and accordingly a local authority vacancy now exists on that Committee, which is required to be filled until the next Annual Authority meeting due to take place in October 2025.
