# 75<sup>th</sup> Anniversary of UK National Parks


Marked the 75<sup>th</sup> Anniversary of National Parks and Access to the Countryside Act 1949.

## 75<sup>th</sup> Anniversary of UK National Parks

Government announcement: strengthened purposes for nature recovery; power of competence; governance reform.

#### 75th Anniversary of the National Parks Act: New legislation to ensure Protected Landscapes are fit for the future

Today is the 75<sup>th</sup> anniversary of the 1949 National Parks and Access to the Countryside Act.

#### **Duty to further guidance**

- Strengthened legal duty became law on statutory bodies and statutory undertakers such as water companies to 'seek to further' national park purposes in performing their functions if they affect national parks.
- Previously they only had to 'have regard for' our purposes.
- Covers over 600 bodies.



### 20<sup>th</sup> Anniversary of the New Forest National Park



We kick off marking the 20<sup>th</sup> anniversary with:

- a celebration of the Hampshire Hedge reaching its half-way milestone
- the Volunteer Fair
- a staff tree planting opportunity to help create a mini Forest at New Park, Brockenhurst.



#### **Protect – First Purpose**

To conserve and enhance the natural beauty, wildlife and cultural heritage of the area



### **Housing figures**

- Revised National Planning Policy Framework includes new housing need figures.
- New Forest District:

**1,501 dwellings/year** = six times the recent average of 246 dwellings/year.

<u>However:</u> 80% of the district is protected green space including the National Park designation...

Working together with other national parks on response to Government's
'Planning Reform Working Paper: Development and Nature Recovery'.



## Planning

- 130 applications received 1 October to 23 December and 133 applications determined (approval rate of 95%)
- Seven appeal decisions received (four dismissed, three allowed).
- 36 new enforcement cases, 48 concluded.




#### **Devolution**

Devolution White Paper sets out plans to change the structure of local government.

A number of aspects could affect national parks:

- More environmental powers for strategic authorities
- New powers to decide on planning applications of strategic importance
- New powers to establish a levy so new developments have associated infrastructure.

- Local Nutrient Mitigation Fund
- Inter Authority Agreement (PfSH)
- Biodiversity Net Gain training and implementation
- Kingwell environmental mitigation scheme at Keyhaven launched (right)



## Future farming in the New Forest update

Farming In Protected Landcapes - extension confirmed for a further year. By March £850,000 in grants will have been given to farmers, commoners and landowners to benefit nature during the scheme started in 2021.

A study on future funding options for commoning has been commissioned by the Future Farming Group and is due to report in March/April.

Commoners Defence Association communications provided by the NPA has seen 97k impressions and 10k engagements on social media since August.



### **Species Survival Fund**

- £1.3m scheme to restore New Forest habitats • and increase wildlife.
- Improving 250 hectares for nature over more than 20 sites – the equivalent of 350 football pitches.
- Six partners (Freshwater Habitats Trust; Amphibian and Reptile Conservation; Commoners Defence Association: Wildlife Trust, Wild New Forest, NFNPA).
- Updated stats from 10 sites surveyed just in:
  - 860 species recorded.
  - 370 animals, 265 plants, and 225 fungi and slime moulds.
  - 150 records of 36 priority species.
  - Nationally-rare species included



## UK Chairs Forum – Nature Recovery update

National parks as 'backbone of nature recovery' and covening 'Team Nature' Ambition:

- 165,000ha for nature recovery across England's national parks
- Investment needed is £800,000,000

To promote opportunities for the understanding and enjoyment of the special qualities of the National Park by the public.



#### **Education and Youth**

Generation Green II:

- £78,000 to work with the Countryside Education Trust, Beaulieu
- funded visits for over 600 eligible young people living in areas of social disadvantage
- enabling them to connect with the National Park.

Visits organised for 610 young people learning about national park management, recreation and special qualities.

### Walking Festival and Rangers

Over 15 organisations organised walks over two weeks in October/November for our Walking Festival. It was well-attended with many sold out, including a walk about commoning (right).

There were walks to suit all interests and abilities, covering topics such as wildlife, photography, archaeology, and the arts.

Rangers engaged with over 2,500 people this period. They took part in partnership Operation Mountie sessions to reduce animal accidents; volunteer and education sessions; and commoning awareness walks.

#### 2024 :

- Supported 11 new organisations in 2024 (including Tottot College, Clay Hills School, Sheiling College, Headway charity, Totton Dementia Hub)
- Community outreach sessions (bike repairs and social rides) at Ashurst base.
- Set to be record year for numbers with people riding later into year: 1145 riders in 134 sessions this quarter.

#### Landscape Connections

Supports long-term projects to boost nature recovery and connect more people to our most treasured landscapes.

Around 20 projects will be invested in over 10 years up to £10m to work with local communities, organisations, landowners and farmers to put entire landscapes and habitats into recovery.

Funding is open to those who care for or can partner with National Parks and National Landscapes.

Process:

- Submit expression of interest.
- Apply for development phase.
- If successful, delivery phase.
